Yng Nghymru, mae cam-drin domestig yn parhau i fod yn achos sylweddol o ddigartrefedd. Yn y cyfnod 2022-2023, nodwyd bod 5,094 o aelwydydd yn ddigartref yn anfwriadol ac mewn angen blaenoriaethol, gan nodi cynnydd o 25% ers y flwyddyn flaenorol.

Yn 2023/24, roedd 46% o aelwydydd a gafodd eu hatal rhag mynd yn ddigartref yn gallu aros yn eu cartref presennol oherwydd cefnogaeth arbenigol gan gynnwys atal cam-drin domestig. (Llyw.Cymru, 2024)

Gall cam-drin domestig fod yn achos digartrefedd ac o ganlyniad i ddigartrefedd, mae mynediad at dai diogel yn hanfodol i gefnogi goroeswyr cam-drin domestig.

Beth yw cam-drin domestig?

Mae Deddf Cam-drin Domestig 2021 yn diffinio'r ymddygiadau canlynol fel rhai sarhaus:

- Cam-drin corfforol neu rywiol
- Ymddygiad treisgar neu fygythiol
- Ymddygiad rheolaethol neu orfodaeth
- Cam-drin economaidd
- Mathau o gam-drin seicolegol, emosiynol neu eraill

Yn ogystal, mae'r Ddeddf yn cydnabod plant o dan 18 oed sy'n gweld, yn clywed neu'n profi effeithiau cam-drin domestig os ydynt yn gysylltiedig â'r dioddefwr neu'r cyflawnwr sy'n oedolyn neu'n cael perthynas riant.

Pa mor hir yw'r cyfnod o gefnogaeth?

Bydd defnyddwyr gwasanaeth yn cael eu cefnogi am 6-12 wythnos.

Gall y rhai sydd angen cymorth ychwanegol gael eu cyfeirio at wasanaethau mewnol ac allanol pellach gan gynnwys Banc Bwyd a Siop Elusennau, Cefnogaeth Arnofiol Cymunedol, Cymorth Allgymorth, Gwasanaethau Plant a Phobl Ifanc, cymorth arbenigol i ddiodefwyr gwrywaidd ac ati.

Ending Rural Homelessness

Ty Rhosyn is a support service that aims to assist individuals who live in rural areas of Carmarthenshire and Ceredigion and who are at risk of Homelessness or who are Homeless due to Domestic Abuse.

Ty Rhosyn Ending Rural Homelessness

The Ty Rhosyn service aims to reduce homelessness or those at risk of homelessness through a period of support through:-

- Early intervention to prevent eviction.
- Advice, information and housing guidance.
- Support with Tenancy, Private Rent, Social Housing, etc.
- Advocacy.
- Specialist support of Homelessness Prevention Officer.
- Access to a specialist housing/referral service in partnership with specialist housing agencies and local authorities.
- Mediation between tenants and landlords and within families (2025)
- Access to a Tenancy Support Scheme (2025/2026)

What can we help with?

- Advice including support with Budgeting, Benefits, etc.
- Housing related support
- Safety Planning / Target Hardening
- Support with engaging with other agencies / educational/ employability courses
- Emotional Support / empowerment and confidence building



In Wales, domestic abuse continues to be a significant cause of homelessness. In the 2022-2023 period, 5,094 households were identified as unintentionally homeless and in priority need, marking a 25% increase from the previous year. (Gov.Wales 2024)

In 2023/24, 46% of households that were prevented from becoming homeless were able to stay in their existing home due to specialist support including domestic abuse prevention. (Gov.Wales, 2024)

Domestic Abuse can be both a cause and consequence of homelessness, access to safe secure housing is vital to supporting survivors of domestic abuse.

What is domestic abuse?

The Domestic Abuse Act 2021 defines the following behaviors as abusive:

- Physical or sexual abuse
- Violent or threatening behavior
- Controlling or coercive behavior
- Economic abuse
- Psychological, emotional, or other forms of abuse

Additionally, the Act recognises children under 18 who witness, hear, or experience the effects of abuse as victims of domestic abuse if they are related to or have a parental relationship with the adult victim or perpetrator.

How long is the period of support for?

Service users will be supported for 6-12 weeks.

Those needing additional support can be referred to further internal and external services including Food Bank and Charity Shop, Community Floating Support, Outreach Support, Children and Young People's Services, Educational Training, Volunteering, Specialist Support for Male Victims etc.

How will my support be facilitated?

Support can be accessed during opening hours Monday—Friday from 9.00 AM—4.30 PM.

Appointments can be; face to face, over the phone or online. Support is also available as a walk in service in local authority buildings such as the HWB in Llanelli, Carmarthen and Ammanford and selected buildings in Ceredigion.
